

## Home Depot Holiday Giveaway

### 1. INTRODUCTION:

The Home Depot and Triton Radio networks (“Sponsors”) are offering the Home Depot Holiday Giveaway (“Sweepstakes”). NO PURCHASE OR OBLIGATION IS NECESSARY.
