

OFFICIAL SWEEPSTAKES RULES

1. INTRODUCTION

Select Registry and Southwest Airlines ("Sponsors") are offering the **Great Escape Promotion** ("Sweepstakes"). **NO PURCHASE OR OBLIGATION IS NECESSARY.** By entering this Sweepstakes, entrants agree to abide by all terms of these Official Sweepstakes Rules and the decisions of Dial Global ("Sweepstakes Administrator") and Sponsors, whose decisions shall be final and binding. **VOID WHERE PROHIBITED.**

2. ELIGIBILITY

This Sweepstakes is open only to individuals who are **21 years of age or older** and legal residents of the United States at the time of entry. Individuals who have already won/qualified from the Sweepstakes Administrator twice in the month of November 2009 are NOT eligible to qualify/win. 3. HOW TO ENTER

The Sweepstakes begins at 2:00 a.m. EST on November 2, 2009 and ends at 05:00 p.m. EST on November 18, 2009 ("Sweepstakes Period"). There are two ways to enter. One way to enter is to call-in to the 800 phone number announced during weekday broadcasts of the "Kool Gold" program (the "Program") during the Sweepstakes Period and play a trivia game on the air. Another way to enter is to log on to: www.bestradiocontest.com. We are not responsible for any technical malfunctions that may occur.

4. WINNER SELECTION

Odds of winning depend on the total number of network phone call and email entries.

Call in entries will receive qualifying prizes for promotional participation.

Random web entries will be drawn and made qualifiers during the sweepstakes period.

Web entries do not receive a qualifying prize.

Grand prize drawing will be conducted by an impartial representative of Sweepstakes Administrator.

Grand prize winner will be selected and called on November 19, 2009.

Grand prize winner will be announced on the air on November 20, 2009.

Each Kool Gold radio station that choose to solicit calls directly to its own local telephone number for this sweepstakes may submit one grand prize entry per local day part, per day, during the Sweepstakes Period (for example, a local affiliate airing a local program during 2 day parts Monday through Friday is allowed 10 grand prize entries each week for a total of 20 grand prize entries during the Sweepstakes Period).

In addition, each Kool Gold affiliate radio station that chooses to collect entries at local live remote broadcasts may submit five entries per remote (no more than two remotes during this Sweepstakes Period) during the duration of the promotion.
